#### Inverness Association – 10 minutes

- 1. County wants a rep to the Coastal Communities Planning Program. To be discussed. Volunteers?
- REPORT: responsibilities would include approx. 6 meetings over 3 years. Important to have someone local. Work will be related to environmental hazards, i.e. sea level rise.
- William Barrett volunteered.
  - 2. Any development proposals to know about?
    - Catherine shared comments from the Design Review Committee regarding the Stenmark Coastal Permit application. No major concerns.
  - 3. Request from CLAM for a letter on their behalf re: bid to County to rehab/take over the Coast Guard Housing and facility in PRS. They are proposing working with Eden Housing
- **ACTION:** Motion (from Kathy) for the board to support CLAM's bid
- Catherine moves, Francine seconds. Unanimous.

### **5minutes**

1. FireWise – Jerry Meral and Robt. Johnston to bring proposals to board to discuss. Participation? Ridge communities' participation? 20 minutes

Jerry Meral spoke about possible FireSafe project for Inverness.

Jerry lives in Sea Haven. There have been 6 fires in last year, all but one were wildfires - one was a house fire. Firewise is active in marin county to get communities to reduce fire risk, encourage home owners to "follow the rules." The way it works: form a committee, rule is must have between 8 and 2500 houses (Yes, that range is correct. Inverness has 1140), need qualified risk assessor, tell property owners what you saw, advise, then create community action plan (clearance, parking, home), must spend \$25 p/home on risk reduction, then apply to be a Firewise community. If measure c passes, there would be money for this. Nothing mandatory about this, if someone doesn't want to do it, you don't have to, don't need 100% buy-in.

IA/IF is the logical Firesafe entity. Not a whole lot of work involved if there is money to hire people. Willing to help in any way if IA takes this on. A big motivation to become firewise is then makes you eligible to apply for grants.

What would be required of IA? Send a mailing, email or website notice (outreach), fiscal agent? (be the umbrella organization for the finances), community-wide mailing to help neighborhood response

Bob Johnston suggests that this should be at the community organizing level, not through the IA. He proposes a scheme: workshop including people who've done community organizing before come and speak and motivate the community to act.

Questions raised: Should the disaster council be the liaison?

No vote, discussion only. Further discussion needed to fully understand the IA/IF involvement and responsibilities.

2. Bagpiper: Discuss our early 2020 edition - 15 minutes

**Discussed responsibilities**. Catherine will help gather and edit stories. Kathy will shepherd the design process through the first week of April. This means that we need to have stories very soon to meet this deadline.
